6. Customer agrees to pay all reasonable attorney fees, collection costs, and court costs incurred by Blue Eagle Equipment, Inc. in enforcing these terms and conditions.
7. Customer authorizes Blue Eagle Equipment, Inc. to obtain credit reports, trade reports, and bank references for the purpose of determining the extension or continuation of credit to customer.
